BURSARY CRITERIA

- 1. Subject to have 5 consecutive years' MISA membership contributions for active members up until date of payment of this benefit, to the institution.
- 2. Only diploma/degree/certificate programmes with a minimum duration of one year to be considered.
- 3. Institutions/Training interventions should be registered with the South African Department of Higher Education or accredited by a SETA.
- 4. Preference will be given:
 - 4.1. to undergraduate (diploma or bachelor's degree) students, prior to post graduate students.
 - 4.2. in respect of courses with Maths, Science, Technical, Financial and scarce skills studies, etc. Applications for courses excluding these subjects may still be submitted, but will only be considered for approval after the closing date, provided there are still bursaries available.
- 5. Bursary Payments:
 - 5.1. Payments shall only be made to institutions directly in respect of cost of studies, e.g. enrolment, subjects and book fees.
 - 5.2. Where study costs are less than R12 500, only the amount of the study costs shall be paid to the institution.
- 6. No applications for previous academic years' studies, accommodation, transport or any other ancillary costs will be considered.
- 7. MISA members' children who are 21 years or older, working or studying part-time, shall not be considered.
- 8. The following categories of students shall not be eligible for the MISA Bursary:
 - 8.1. Masters or doctoral (PHD) degrees;
 - 8.2. Bridging courses;
 - 8.3. Repeating studies due to previously having failed or abandoning studies;
 - 8.4. Unsatisfactory results during previous period of studies (i.e. obtained less than 50 % for any of the subjects);
 - 8.5. Student suspended or have disciplinary proceedings instituted against him/her;
 - 8.6. Students registered at educational institutions outside of South Africa.
